# CODIFICATION OF ORDINANCES FOR THE VILLAGE OF MATTAWAN ORDINANCE NO. 139

An Ordinance to adopt by reference a Code of Ordinances for the Village of Mattawan, Amendments to the Uniform Traffic Code for Michigan Cities, Townships and Villages and providing for punishment for those violating ordinances of the Village of Mattawan.

## THE VILLAGE OF MATTAWAN HEREBY ORDAINS:

## **SECTION 1**

The twelve chapter book of Village Ordinances containing all previously adopted ordinances of the Village of Mattawan shall be and hereby is codified into a single volume which shall be known as the "Code of Ordinances for the Village of Mattawan", said code regulating among other things, but without limitation, matters of housing, construction, environmental protection, zoning, nuisance, public works and crimes and offenses.

#### SECTION 2

Ordinances within the code shall continue to bear and be cited by the Ordinance numbers contained within the code. For state and uniform codes adopted by reference, mention of or reference to the "governmental unit" or similar designations shall mean the Village of Mattawan or agencies or departments within the Village as the context requires.

## **SECTION 3**

The Uniform Traffic Code for cities, townships and villages promulgated by the Director of State Police and published in the 1979 edition of the Michigan Administrative Code and amendments as published in the Quarterly Supplement No.5 to the 1979 edition of the Michigan Administrative Code, in accordance with Public Act 62 of 1956, State of Michigan and all amendments thereto through enactments of the State legislature up to and including Public Act 362 of 1993, except as modified by other ordinances within the "Village of Mattawan Code of Ordinances" as adopted herein.

# **SECTION 4**

The Village Clerk shall publish this ordinance in the manner required by law and shall at the same time publish a supplementary notice setting forth the purpose of the Village of Mattawan Code of Ordinances and Uniform Traffic Code and of the fact that a complete copy of the Codes are available at the office of the Clerk for inspection by the public at all times.

# **SECTION 5**

Whenever a provision of an ordinance within the Village of Mattawan Code of Ordinances or the Uniform Traffic Code shall be deemed a "misdemeanor", the offender may be punished by imprisonment for not more than 90 days or a fine of not more than \$500.00 or both and may be ordered to pay court costs.

## **SECTION 6**

All other ordinances inconsistent with the provisions of this ordinance, ordinances as codified in the Village of Mattawan Code of Ordinances and the Uniform Traffic Code are, to the extent of such inconsistency, hereby repealed.

# **SECTION 7**

The Uniform Traffic Code will be in effect in this governmental unit 20 days after the passage of this adopting ordinance.

# **SECTION 8**

This Ordinance shall become effective on 09/30/94.
