VILLAGE OF MATTAWAN UNIFORM TRAFFIC CODE ORDINANCE ORDINANCE NO. 1

An Ordinance to adopt by reference the Uniform Traffic Code for Michigan Cities, Townships and Villages.

THE VILLAGE OF MATTAWAN ORDAINS:

SECTION 1 CODE ADOPTED:

The Uniform Traffic Code for cities, townships and villages promulgated by the Commissioner of State Police on February 14, 1958, and published in Supplement No. 13, and on February 14, 1961, published in Supplement No. 25 to the 1954 Michigan Administrative Code in accordance with Public Act 62 of 1956, State of Michigan, is hereby adopted by reference as in this ordinance modified. SECTION 2 NOTICE OF ADOPTION OF AMENDMENT TO THE UNIFORM TRAFFIC CODE BY THE VILLAGE OF MATTAWAN, VAN BUREN COUNTY, MICHIGAN.

The amendments of the Uniform Traffic Code for Cities, Townships and Villages as promulgated by the Commissioner of the State Police in reference to the said Uniform Code are hereby adopted by reference and made a part of the Traffic Code for the Village of Mattawan, Michigan. (Ord. No. 26, adopted June 12, 1972, amended by Ord. No. 54, eff. October 12, 1982)

SECTION 3 REFERENCE IN CODE

Reference to the Uniform Traffic Code for Michigan Cities, Townships, and Villages and amendments thereto to governmental unit shall mean the Village of Mattawan. (Ord. No. 1, eff. March 26, 1962, amended by Ord. No. 24, eff. Feb. 19, 1970, amended by Ord. No. 26, eff. June 12, 1972, amended by Ord. No. 54, eff. Oct. 12, 1981)

SECTION 4

The purpose of such Code is to regulate the operation of vehicles, to provide for the regulation and use of streets, highways and alleys and other public and semi-public places within the Village of Mattawan and to provide penalties for the violation of said Code. (Ord. No. 26, adopted June 12, 1972)

SECTION 5

Complete copies of the Uniform Traffic Code are available at the office of the Village Clerk for inspection by and distribution to the public at all times. (Ord. No. 26, adopted June 12, 1972)

SECTION 6

No further or additional publication of the Uniform Traffic Code is required or contemplated. (Ord. No. 26, adopted June 12, 1972)

SECTION 7 SEVERABILITY:

The provisions of this Ordinance are hereby declared to be severable, and if any clause, sentence, paragraph, section or subsection is declared void or inoperable for any reason, it shall not affect any other part or portion thereof. (Ord. No. 17, eff. Oct. 4, 1966)

SECTION 8 REPEAL:

All Ordinances or parts of Ordinances in conflict herewith are hereby repealed. (Ord. No. 1, eff. March 26, 1962, Ord. No. 17, eff. Oct. 4, 1966, amended by Ord. No. 24, eff. SECTION 9 PENALTIES:

As expressly provided by this Ordinance of the Village of Mattawan, every person who is convicted of a misdemeanor violation of this Code for the offenses of operating a motor vehicle under the influence of liquor or drugs (UTC § 5.15), or of the offense of driving a motor vehicle with a suspended or revoked operator's license (UTC § 5.62 and 5.62a) shall be punished by a fine of not more than \$500.00, or by imprisonment for not more than ninety-three (93) days, or both. All other misdemeanor convictions hsall be punishable by a fine of not more that \$500.00, imprisonment of not more than ninety (90) days, or both. All other provisions of village of Mattawan Ordinance No. 1 shall remain in full force and effect. (Ord. No. 1, eff. March 26, 1962, amended by Ord. No. 17, eff. Oct. 4, 1966, amended by Ord.
