Rob Brooks asked if the retention pond in Powell's Development is large enough and wanted to know if that is causing more flooding. He also asked if the debris in the creek could be cleaned out.

Residents of Western Avenue explained that they since the building started for the new schools they are now getting flooded and they never used to. Engineer Woodhams explained that the Village is not responsible for approving the site plans for the schools. The Village only approves the connection to water and sewer and driveways, nothing more. Many of the residents have been trying to communicate with representatives from the school to get the problems resolved but do not feel like they are getting anywhere. The residents are asking the Village for any additional support.
